Comparison of the Republican & Democrat Platforms

Human Life

Republican Platform: "The Constitution's guarantee that no one can "be deprived of life, liberty or property" deliberately echoes the Declaration of Independence's proclamation that "all" are "endowed by the creator" with the inalienable right to life. Accordingly, we assert the sanctity of human life and affirm that the unborn child has a fundamental right to life which cannot be infringed. We support a human life amendment to the Constitution and legislation to make clear that the Fourteenth Amendment's protections apply to children before birth." (p. 13)

Democrat Platform: "Democrats are committed to protecting and advancing reproductive health, rights, and justice. We believe unequivocally that every woman should have access to quality reproductive health care services, including safe and legal abortion—regardless of where she lives, how much money she makes, or how she is insured. We believe that reproductive health is core to women's, men's, and young people's health and wellbeing. . . We will continue to oppose—and seek to overturn—federal and state laws and policies that impede a woman's access to abortion, including by repealing the Hyde Amendment." (p. 37)

Planned Parenthood

Republican Platform: "We oppose the use of public funds to perform or promote abortion or to fund organizations, like Planned Parenthood, so long as they provide or refer for elective abortions or sell fetal body parts rather than provide healthcare." (p. 13)

Democrat Platform: "We will continue to stand up to Republican efforts to defund Planned Parenthood health centers. . ." (p. 37)

Judges

Republican Platform: "We support the appointment of judges who respect traditional family values and the sanctity of innocent human life." (p. 13)

Democrat Platform: "We will appoint judges who defend the constitutional principles of liberty and equality for all, protect a woman's right to safe and legal abortion. (p. 25)

Medical Research

Republican Platform: "We call for expanded support for the stem cell research that now offers the greatest hope for many afflictions—through adult stem cells, umbilical cord blood, and cells reprogrammed into pluripotent stem cells—without the destruction of embryonic human life. We urge a ban on human cloning for research of reproduction, and a ban on the creation of, or experimentation on, human embryos for research." (p. 37-38)

Democrat Platform: "Democrats believe we must accelerate the pace of medical progress, ensuring that we invest more in our scientists and give them the resources they need to invigorate our fundamental studies in the life sciences in a growing, stable and predictable way. . . (p. 36) Even though a human life is destroyed in embryonic stem cell research, the Democrat Party believes in it.
