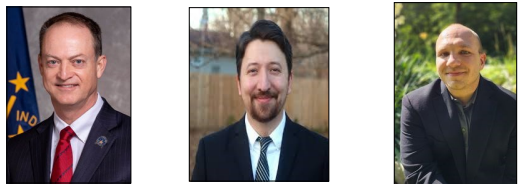

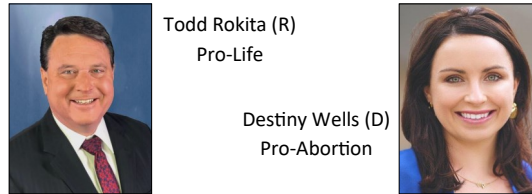

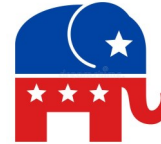

**Republican Platform**

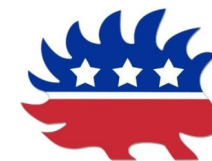
**Democrat Platform**
